**Public Hearing: Review of Blue Lake Municipal Cod and Proposed Ordinance No. 527**

The Mayor opened the public hearing at 7:09 p.m. There was no public comment. The public hearing closed at 7:10 p.m.

**Ordinance No. 527: An Ordinance of the City Council of the City of Blue Lake Adopting the Blue Lake Municipal Code – Second Reading and Adoption**

Daugherty/Ricca *motion for a second reading and adoption of Ordinance No. 527: An Ordinance of the City Council of the City of Blue Lake Adopting the Blue Lake Municipal Code, by Title Only.* The motion passed unanimously. The Mayor gave a second reading of the Ordinance by title only.

**Proclamation Human Rights Awareness Month – December 2017**

A member of the Humboldt County Human Rights Commission was available to present and accept the proclamation. General questions of the Council were answered.

Ricca/Mackay *motion to proclaim December 2017 as Human Rights Awareness Month.* The motion passed with the following vote: Ayes: Mackay, Jones, Ricca, Daugherty Nays: Lynch. Mayor Jones read the proclamation. Due to a couple of typographical errors were found, the proclamation will be signed once typographical errors are fixed.

**Presentation of Hatchery Road Safety Assessment**

Erica Gray, resident on Hatchery Road outside of City Limits, made a presentation of a project to assess the safety of Hatchery Road, both inside and outside City Limits. It was noted that there would be a community walk on January 26 starting at the Logger Bar, and that a survey was available online to gather community input. The City Manager gave some examples of specific issues on Hatchery Road within City Limits.

She also gave an update on the Power's Creek District, a special project at the Blue Lake Emporium, and the City's new half time deputy starting January 15, 2018.
