Each spoke to the frustrations they were experiencing concerning an alleged unregistered motorcycle that was traveling on the City's recreation trails behind the industrial park and on the levees. Both people lived in close approximation to Powers creek and relayed that the motorcycle was using the trails as a means of travel and was riding the trails after dark. One member brought the City's Parks and Recreation Ordinance (# 263) as support for this activity as being illegal. Secondly, it was reported that people had been "hanging out" in the areas where the city had cleared brush near Power's creek. There was a general discussion about the issue.
