

RESOLUTION NO. 1100

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BLUE LAKE ADOPTING PERMIT APPLICATION FEES FOR MARIJUANA CULTIVATION WITHIN THE CITY OF BLUE LAKE AND PROVIDING AN EFFECTIVE DATE OF OCTOBER 26, 2017

WHEREAS, the City of Blue Lake has adopted Ordinance No. 526 governing the cultivation of marijuana within the City limits; and,

WHEREAS, Ordinance 526 requires a City issued permit to cultivate marijuana within the City limits; and,

WHEREAS, Ordinance 526 allows the City to establish by resolution an application fee to be charged to the applicant to cover the costs to the City to process, review, and issue permits; and,

WHEREAS, the City of Blue Lake adopted Resolution Number 969, Effective February 1, 2011, requiring various deposits to cover the cost of planning, zoning and land use approvals, and establishing other miscellaneous charges; and

WHEREAS, City Staff has conducted a cost recovery analysis which indicates that the revenue does not exceed the cost of administration,

THEREFORE, BE IT RESOLVED by the City Council of the City of Blue Lake that the following Marijuana Cultivation Permit Fee Schedule will become effective on October 26, 2017:

1. Marijuana Cultivation Permit Application Fee Deposit is \$160
2. Applications that require additional review beyond what has been identified under the initial application review process will be charged on a cost recovery basis;
3. Additional permits and fees may be applicable based upon the scope and nature of the project and are covered under the City's fee schedule adopted under Resolution No. 969, Section 4.
4. All Application Fee Deposit is non-refundable.

BE IT FURTHER RESOLVED that this resolution will be filed with the City Clerk and that certified copies will be posted within three public places within the City of Blue Lake.




