January 28, 2014

The Blue Lake City Council met in regular session at 7:02 p.m. on January 28, 2014. Mayor Sherman Schapiro called the meeting to order. Council Members present were Stephen Kullmann, Greg Sawatzky, and Kevin Benjamin. Others present were City Manager John Berchtold and City Clerk Adrienne Nielsen. Councilmember Lana Manzanita was absent.

Motion to Approve Agenda

Councilmember Kullmann moved, seconded by Councilmember Benjamin to approve the agenda with moving item 5 after item 3. The motion carried unanimously.

Public Input

Walter Nystrom, Plant Manager at Blue Lake Power, commented to Council on the Planning Commission not coming to a conclusion on the Roundstock item, but was glad to see it was going to be re-scheduled.

Consideration of Applicants for Parks and Recreation Commission (Action)

Councilmember Kullmann moved, seconded by Councilmember Sawatzky to approve Nathan Blum and Jennie Short be appointed to Parks and Recreation Commission to the term ending January 30, 2016. The motion carried unanimously.

SHN Greenwood Road Geometric Assessment Report of Findings – Questions by Citizen Sherman Schapiro (Discussion/Action)

Mike Foget, City Engineer, started the discussion by stating that the Greenwood Road Geometric Assessment report is in draft stage. Citizen Sherman Schapiro stated he objects to Mike Foget's reporting on the report to Council. City Manager Berchtold explained that the report is seen as a technical memorandum. In conclusion, Council requested that the City Engineer edit the report summary with the edited paragraph provided by Mr. Schapiro, have a Google image showing the structure on the parcel, and have the supplemental information stamped by Mike Foget with the corrections to the report.

Councilmember Benjamin moved, seconded by Councilmember Kullmann to approve Budget Adjustment 2014-1. The motion carried unanimously.

Councilmember Sawatzky – Discussion of Industrial Park Sales (Discussion)

Council had discussion of the Industrial Park in regards to what could be done with it. Zoning in regards to light manufacturing and heavy manufacturing descriptions, parcel maps and presentations from Humboldt Made and Dave Wells Commercial were requested by Council for future meetings.
