July 8, 2014

The Blue Lake City Council met in regular session at 7:03 p.m. on July 8, 2014. Mayor Sherman Schapiro called the meeting to order. Council Members present were Stephen Kullmann, Michele McCall-Wallace and Kevin Benjamin arriving at 7:23 p.m. Others present were City Manager John Berchtold and City Clerk Adrienne Nielsen. Lana Manzanita was absent.

Motion to Approve Agenda

Councilmember McCall-Wallace moved, seconded by Councilmember Kullmann to approve the agenda after removing item 6 and 7 to a future agenda. The motion carried unanimously.

Public Input

Frank Onstine from the Old Crows Group, would like to replace rock near the new bench on Hatchery Road. City Manager Berchtold will work on this issue. R&B Auto came to follow up on a complaint regarding greenery blocking the view at the intersection of Chartin and S. Railroad. City Manager Berchtold reported the concern to the property owner, Blue Lake Rancheria.

Argument in Favor Of Utility Users Tax Ordinance No. 510 (Discussion/Action)

After discussion and editing to the argument in favor of Utility Users Tax Measure T provided to Council by Mayor Schapiro, Councilmember McCall-Wallace moved, seconded by Councilmember Kullmann to approve the argument in favor of Measure T and to move the argument to City Attorney Nancy Diamond for review. The motion carried unanimously. Councilmember McCall-Wallace moved, seconded by Councilmember Kullmann to have "CARE participants" replace "low income individuals" in the text of the document as well. The motion carried unanimously.

After discussion, Councilmember Kullmann moved, seconded by Councilmember Benjamin to accept the Utility Users Tax Fact Sheet with all edits mentioned. The motion carried unanimously. Council congratulated City Manager Berchtold on his recent recognition of forty years of public service from the International City Managers Association.
