Proclamation: Domestic Violence Awareness Month

Brenda Bishop from Humboldt Domestic Violence Services came to present and accept the proclamation.

Daugherty/Mackay motion to proclaim October as Domestic Violence Awareness Month. Motion carried unanimously.

Public Hearing: Unmet Transit Needs

It was noted that the end of the public comment period deadline would be October 31, 2017.

The Mayor opened the public hearing at 7:15 p.m.

Tina Catalina commented that the bus doesn't run on Saturday and Sunday, but wondered if a Blue Lake stop could be tied in with the Willow Creek bus, perhaps one drop off in the morning and a pick up in the evening, to and from Arcata. She also noted that the last bus to Blue Lake on Friday from Arcata is at 5:35 p.m. and the first one out of Blue Lake on Monday is at 7:15 a.m.

Ray Stonebarger, Blue Lake Fire Chief: Presentation on Fire District Special Tax Measure Y

Fire Chief Stonebarger gave a full presentation on the Measure Y Tax, how the money from the tax would be spent, and mentioned that another public hearing regarding Measure Y would take place at the Fire Hall on November 1, 2017 at 6:30 p.m.

Review of Humboldt County General Plan Update Proposed Land Use Designation Revisions

Garry Rees, City Planner, was present to explain the proposed update to the County general plan. He passed out larger maps for the public and council to review. It was noted that there would be a first hearing on October 24, 2017 in the Humboldt County Supervisors Chambers.

Resolution No. 1100: A Resolution of the City of Blue Lake Adopting Permit Application fees for Marijuana Cultivation within the City of Blue Lake and Providing and Effective Date of October 26, 2017 City Manager Mager gave an overview of the proposed resolution and the draft permit application.

Council asked to have it specified on the permit that the fees for the permit would be a one-time fee; that permit holders would not be required to get an annual permit.

Mackay/Daugherty motioned to approve Resolution No. 1100: A Resolution of the City of Blue Lake Adopting Permit Application fees for Marijuana Cultivation within the City of Blue Lake and Providing and Effective Date of October 26, 2017. Motion approved unanimously.

Jones – reported on the Blue Lake School presentation. She noted that the Humboldt County Association of Governments (HCAOG) meeting will be the following week, and announced the Museum Salad Luncheon for October 26, 2017.

Daugherty - Nothing to report

City Manager Mager – Mentioned a call for proposals for HCAOG and noted that the City may not qualify alone, but that a partnership with the County and City of Arcata may be possible for a traffic analysis of Hatchery Road. She also mentioned the new artist's collective at the Blue Lake Emporium, and announced that they are working on a "Taste of Blue Lake" on November 4, 2017 and the Blue Lake Chamber Mixer on November 15, 2017
