Recommendation from Parks and Recreation Commission regarding Naming of Park at Corner of Broderick and Chartin

Bettina Eipper and Darcey Lima from the Parks and Recreation Commission were present to discuss the agenda item. They gave a little background on the Rodda Family, who originally bequeathed the land to the City of Blue Lake for the Horse Arena (originally full rodeo grounds) and other recreation facilities.
