Blue Lake Public Safety Commission: Work Plan Item Update on Table Top Exercise

City Clerk Sousa gave an overview of the work plan item, and asked if two (2) members of council would like to participate on the subcommittee. Mayor Jones and Councilmember Hogan stated they would be interested in participating. This was confirmed by consensus of the Council.

Discussion regarding Traffic Ordinance Regulations and Language

City Manager Mager handed out a report with researched options for review regarding regulations on unhitched trailers. The Council chose option 3, which included regulations on a time limit and distance for trailers to be moved. The Ad Hoc committee of Councilmembers Hogan and Daugherty will meet to discuss these specific regulations to bring back to the Council.
