#### **Small Business Loan Proposal**

City Manager Mager gave an overview of the work being done with the Hudson family and the plan for a loan. It was noted that the de-federalized Community Development Block Grant (CDBG) moneys have been historically used for similar projects.

Daugherty/Curran motion to authorize the City Manager, in consultations with the City Attorney and City Accountant, to negotiate and enter into a small business loan with a qualified entity for the development of a coffee shop and café with the loan amount to not exceed \$10,000.00. The motion carried unanimously.

#### **Campground Development**

City Manager Mager explained the process of looking at lodging for a recreation community. She passed out some visual concepts of a proposed location and ideas for a campground project. It was noted that this is an opportunity to implement a small pilot project to get some market data to see if it is a viable project.

Daugherty/Ricca motion to authorize the City Manager to pursue the development of a campground and bring back to Council an implementation plan and budget for consideration. The motion carried unanimously.
