#### 3. Public Input:

- David Seda: Questioned why the City placed boulders in the area adjacent to his father's
  property; understands that the City is trying to clean up the property and that his father
  continues to store items in this area and that the boulders will prevent items from being
  placed there
- **4.** Public Hearing Continuation: Amendment of the General Plan Land Use Element and Title 17 (Zoning) of the Municipal Code to add an Opportunity (O) Zone that would allow a variety of commercial, manufacturing, and residential uses. The O Zone is proposed to be applied to several properties within the Powers Creek District (formerly Blue Lake Business Park) and adjacent areas that are currently zoned Industrial (M), Light Industry (ML), and Agriculture Exclusive (AE). The Land Use Element is also proposed to be comprehensively updated as part of these amendments.

#### **Staff Presentation:**

Garry Rees, City Planner, presented the changes to the Opportunity Zone, as requested by the City Council; changes include adoption of the National Dark Skies Standard (IDA) and lowering of light pole heights.

**Building Height Discussion:** City Manager Mager presented various building heights for Council's viewing; the heights represented various local development in order for Council to

have a better understanding of development. The number of stories is also a limiting factor and it is recommended that the building height be the limiting factor and not the number of stories. The Opportunity Zone has many checks and balances as identified by City Planner Garry Rees to prevent development that doesn't fit with the city's development plans. The proposed height restriction of 25 feet would be the most restrictive height limitation in the City.

# Mayor Jones opened up the discussion for public input:

**Public Comment:** Alicia Rousseau-likes the flexibility with the additional height; this will allow them more creativity as they develop their property.

**Public Comment Closed.** Council recommends adopting a 45 foot height limit with the shadow analysis as a requirement for any development over 25 feet; Council directs staff to revise the language to reflect the proposed height limitation with the established set back of 25' from the trail; remove the limitation on the number of stories to allow additional architectural creativity. The Opportunity Zone will be brought
