**RESOLUTION NO. 1184**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BLUE LAKE  
AUTHORIZING THE CITY MANAGER TO AWARD CONTRACT FOR  
EMERGENCY REPAIRS TO THE WASTEWATER TREATMENT PLANT**

WHEREAS, the City maintains and operates a wastewater treatment plant (“WWTP”) for the benefit of the City residents and businesses;

WHEREAS, in or about 2007, due to the accumulation of algal blooms in the WWTP settling ponds during periods of low flows and high temperatures, the City implemented a rock filtering system using pea gravel;

WHEREAS, the City has discovered that the void spaces between the pea gravel is plugged with algae, causing decreased effectiveness of the filtering system;

WHEREAS, it is imperative that the pea gravel be replaced with larger rocks immediately to prevent increased levels of Total Suspended Solids (TSS) and Biochemical Oxygen Demand (BOD); which if not addressed will jeopardize the City’s compliance with State Water Quality permit levels and subject the City to additional fines and penalties;

WHEREAS, due to the need to take urgent action, the City Council finds that there is insufficient time to award a contract for the necessary work through formal bidding procedures;

WHEREAS, the City Manager solicited bids from at least three contractors capable for performing the work as follows: \$60,125.00 from Wahlund Construction, Inc.; \$47,381.00 from RAO Construction, Inc; and \$44,860.50 from Robinson Trucking and Equipment, LLC;

WHEREAS, the City Manager identified Robinson Trucking and Equipment, LLC, as the apparent lowest bidder and has requested that the City Council authorize the City Manager to execute a public works contract in the total amount of \$44,860.50 with Robinson Trucking and Equipment, LLC to perform the work;

WHEREAS, the Council finds that the public interest and necessity demand the immediate expenditure of public money to safeguard life, health, or property and further finds that the award of the project is justified pursuant to Public Contract Code sections 20168 and 22050.

NOW, THEREFORE, the City Council of the City of Blue Lake finds, declares, and resolves as follows:

Based upon the foregoing recitals, which are hereby incorporated as findings of the City Council, the City Manager is authorized to award a public works contract to Robinson Trucking, LLC in the total amount of \$44,860.50 to complete the necessary work to the wastewater treatment plant rock filtering system, as recommended and directed by the City Engineer. The City Manager is further authorized to execute a public works contract with Robinson Trucking and Equipment, LLC in a form approved by the City Attorney.
