NOTICE OF PUBLIC HEARING

Notice is Hereby given that the **Planning Commission of the City of Blue Lake** will conduct a Public Hearing on the following general plan amendment at a special meeting on **March 14, 2022.**

Amendment of the General Plan Housing Element to comply with State housing

law: State law requires cities in Humboldt County to update their General Plan Housing Element for the 2019 - 2027 planning period. The City of Blue Lake is preparing a Draft Housing Element which includes an analysis required by State law related to: 1) a review of past accomplishments under the last Housing Element update adopted by the City; 2) existing demographics and housing characteristics; 3) land, financial and, administrative resources available to meet housing demand; and 4) market, government, and environmental constraints. The Humboldt County Association of Governments (HCOAG), a regional planning agency, is responsible for allocating the Regional

(HCOAG), a regional planning agency, is responsible for allocating the Regional Housing Need Assessment (RHNA) to individual jurisdictions within the County. The RHNA is distributed by income category. The City of Blue Lake has been allocated a RHNA of 23 dwelling units (7 very low, 4 low, 5 moderate, and 7 above moderate income units). The Housing Element itself does not create physical residential growth in the City. The City must ensure the availability of residential sites at adequate densities and appropriate development standards to accommodate the RHNA. The Draft Housing Element identifies available sites for residential development during the 2019 - 2027 planning period, which exceed the City's RHNA allocation, including sites located within

In accordance with the Governor's Executive Orders N-25-20 and N-29-20, the Planning Commission shall conduct the Planning Commission meeting by Teleconference via Zoom on Monday, March 14, 2022 at 7:00 p.m. Public input can be given to the Planning Commission by emailing citymanager@bluelake.ca.gov until 4:30 p.m. on Monday, March 14, 2022.
