 - a. Parks and Recreation Update ~ Parks and Recreation Director Wood provided the following update: Prash Hall upgrade project continues and is almost complete. There are lots of events coming up (Logger Bar Block Party on Oct 21st, BYC Fest October 14, Hoptoberfest September 30th, etc.). Wood bat baseball begins September 23rd. Will be adding new signage advising of overnight parking restrictions, etc.

Hana Padilla, potential business operator is talking with the property owner. Both parties are very optimistic. Hana is working on her business plan and exploring organizational structuring and financial options.

6. Discussion on Downtown Vacancies and Under-Utilized Retail/Commercial Properties ~

The Commission discussed the pros and cons of implementing a vacancy tax. There are several key buildings currently vacant and/or underutilized that impact the economic health of the downtown. Some communities collect the tax and give the funds back to the property owner in the form of a grant to make the improvements. It was suggested Commissioners reach out to the property owners to identity their needs and potential funding opportunities to upgrade their structures. First step could be to provide a notice to the property owners encouraging them to upgrade within a certain time frame.

The current status of Dell'Arte was discussed and what is the City can do to assist them, such as looking at street design to provide additional parking. Suggested the Chamber maybe interested in assisting with a fundraising event with Dell'Arte. Put on a future agenda.

Public Comment: Councilmember Elise Scafani asked about the City sponsoring a fundraiser for Dell'Arte, such as dance, potluck dinner at the donated Prash Hall. Important to have City Hall show support.
