Commissioners absent: none

1. Establish a Quorum of the Commission - Meeting called to order at 7 p.m. by Chair Commissioner Jones. **Quorum established.**

2. Motion to Approve Agenda - Motion to approve the agenda was made by Commissioner Glen and seconded by Commissioner Schang. All were in favor.

3. Public Input - Public Input solicited by Chair Jones. No public input received.

4. Approval of Minutes - Chair Jones asked for additions and/or changes to the minutes of November 3rd, 2026 as submitted by Commissioner Hales.

Item 8. Chair Jones clarified that the Safe Routes workshop was specific to the Blue Lake Rancheria.

Item 16. Commissioner Glen asked to change it to "Future agenda items: none."

Note: Regarding the Safety Fair date, Commissioner Glen brought up the Commission's decision to return to the successful 2024 date – the second Saturday of September – and agreed to ask Parks and Recreation to reserve that date for 2026 soon.

Motion to accept the minutes with changes was made by Commissioner Ricca and seconded by Commissioner Schang. All were in favor.

5. Blue Lake Pods Grassroots Emergency Preparedness and Response – A presentation was made by Pod representatives Dot Campbell, Anne Holcomb, and Laura Chapman. There are currently 3 functioning Pod neighborhood groups in Blue Lake. The Pod leaders would like to help more Pods form. Interested people were encouraged to contact Pod leaders.

Commissioner Glen added that she is also a Pod leader and noted that some of the Pods also incorporate Neighborhood Watch principles.

Commissioner Ricca asked if Pods would be able to distribute the No New Year's Eve Fireworks posters and the representatives agreed.

6. Agency Check-In

Blue Lake Volunteer Fire Department representative Talia Flores gave the monthly incident report and announced that several spots are open in the BLVFD's December CPR/First Aid class. Classes are available monthly. CPR costs \$40 and CPR/First Aid is \$70 and are a combination of online instruction and a classroom-based skills test. BLVFD also offers a free smoke alarm program that includes free installation and a smoke-alarm inspection program.

Red Cross – Janeen Hess, District Program Manager for Humboldt/Trinity/Del Norte, and Chris Hitchcock, Gold Country Shelter Lead reported. Red Cross coordinates disaster group shelters, offers monetary and other support for wildfire and home fire victims, installs smoke detectors, and offers disaster preparedness education. Chris suggested that the best shelter location for Blue Lake would be the Rancheria.

Sheriff - No representative. Commissioners reviewed and discussed the monthly Sheriff's Report in their packets - one standard incident list and one visual map. **Commissioners would like to get both styles of reports monthly.**

Rancheria – No representative.

7. Refrigerator Emergency Magnets – Chair Jones showed a mock-up and reported that she asked for and received donations for printing the magnets - \$100 each from the WhaNikas and the Mad River Grange - which covered all costs. Paradise Cay will print 500 and they will be available at City Hall. **Chair Jones will report this to the City Council during Public Comment at the next meeting.**

8. I Street Survey Next Steps Chair Jones reported that she, Commissioner Hales, Mayor John Sawatsky, and Theresa Sawatsky distributed surveys to homes in the I and J St neighborhood on 11/15 – return date 12/22. **Commissioner Hales will collect surveys from City Hall, tally, compile all comments, and results will be discussed at the 1/5/26 PSC meeting.**

9. Increase of Speed Bumps Throughout City Commissioner Ricca and Don Bednar submitted a map of 6 requested speed bumps/humps in the A street neighborhood to control speed. The commissioners discussed: the difference between speed bumps and speed humps, the city manager's ballpark estimate of \$36,000 per bump/hump, and the similarity to the earlier I St. neighborhood speed control request. **Commissioner Ricca will develop a draft survey for the A St. neighborhood for the next PSC meeting. The Commission will ask the City Engineer to review the A St. request and the Commission may consider developing a general process for future similar requests that includes a neighborhood survey.** Talia Flores commented earlier that speed bumps/humps on city streets are not a problem for BLVFD vehicles.

10. New Year's Eve Poster Concerning Fireworks – After a discussion, **motion was made by Commissioner Hales and seconded by Commissioner Ricca to have 150 copies of the No New Year's Eve fireworks poster printed and disseminated - paid for by Commissioner Ricca, have a banner printed by Paradise Cay - paid for by Commissioners Ricca and Hales, and to post the**

banner on the Museum's lawn after December 20 with permission from the museum. All were in favor.

-Chair Jones will report on this item to the City Council at their next meeting during Public Comment.

11. PS Commissioner Reports – Chair Jones noted that the terms of Commissioners Jones, Ricca, and Hales expire on January 30, 2026. **This will be discussed at the January meeting.**

Commissioner Glen shared a flyer from the City Manager on a December 3rd community workshop on road safety and community connection. **Commissioner Glen will try to attend.**

12. Report from PSC Liaison & Staff City Council Liaison Scafani reported that the City Council is discussing a significant budget deficit and also that the Interim City Manager Jill Duffy will run out of hours in early January.

13. Future Agenda Items –

13. Motion to Adjourn – **Motion to adjourn was made by Commissioner Hales and seconded by Commissioner Ricca. All were in favor.**




