1. Meeting Called to Order: 7:00pm

Quorum of the commission established.

2. Approval of the agenda as presented:

3. Public Comment: No Comments

Public comment closed.

4. Illegal Fireworks Discussion: City Manager Mager presents the item and explains the difference between California's Safe and Sane Fireworks and the illegal fireworks that are causing issues in the community.

The commissioners discuss the effects of the illegal fireworks and the difficulty associated with finding where and who is lighting them. The commissioners discuss the lack of enforcement due to short staffing at the Sheriff Department and the fact that illegal fireworks are happening all over the County and not just in Blue Lake. Commissioner Jones talks about education and providing the community and the children with information on how the fireworks effect animals and the public. The commission could develop posters and conduct community outreach.

Public Comment:

Rebecca Collins: States her support of community outreach and education.

Mardi Granger: Presents the commission with her plan to educate the community; including ringing the bell at the church during the fourth of July and working with the school to develop a flyer to send home with the school children.

Public Comment Closed.

Liaison Scafani: States that the Council had discussed the formation of a citizen's taskforce to go door-to-door to educate the community.

The commission talks about the development of a campaign, including yard signs and posters.

5. Humboldt County Sheriff Call Data Review and Discussion:

The commission reviewed the call data provided by the Sheriff Department; the commission did not see any issues of concern.

6. Agency Check-In:

The City Manager presents a brief update on the Fire Department; including the need for additional volunteers that live in the community.

The commission discusses their individual neighborhood systems and they discuss how CERT could be engaged to help the neighborhoods with disaster preparedness and planning. The commission concludes that the neighborhoods must be sharing information and that the City can continue to provide information if requested.

7. I Street Improvements and the Local Road Safety Plan

The City Manager provides an overview of the City's Local Road Safety Plan and how the plan can be used to address traffic safety issues in the City. The plan was developed and adopted by the City and presents reasonable and affordable options to address issues. I street was identified in the plan and several options were discussed to improve safety. These options included a mini-roundabout, parking changes, landscape installations and signage. The City will be addressing I Street and G Street in fiscal year 25-26 and will be using the plan to direct improvements.

Commissioner Ricca comments on the round-about on the boulevard and the vegetation that is blocking the view of on-coming traffic.

Liaison Scafani comments on I Street and the neighborhood outreach; before anything goes forward it should be revisited; there were requests made for speed signs and a four way stop sign.

Rebecca Collins: Comments on people running the stop signs by her house; they don't work as people run right through them.
