### Blue Lake Public Safety Commission Meeting-November 13, 2023

Meeting called to order: 7:00 PM

### 1. Establish a quorum:

Commissioners Present:

### 2. Motion to approve agenda as presented

Commissioner Dickinson motioned Commissioner Nava 2nd Approved by consensus.

### 3. Public Input - none

### 4. Review Meeting Minutes from Previous Meetings-Discussion Minutes Approved

Commissioner Nava motioned to approve meeting minutes from September, 2023 Commissioner Cruz 2nd

Approved by consensus.

### 5. PSC Resignations

Two members of the commission have resigned due to relocating out of Blue Lake; both commissioners stated that they could not find housing in Blue Lake.

City Manager Mager: Commented on the two vacancies and encouraged the commissioners to recruit applicants. Applications can be turned in prior to the next Council meeting for consideration. The vacancies are posted and the City and the commission can do additional outreach.

### Public Input - none

### 6. Sheriff Contract Update-Discussion

The commission discussed the Sheriff's proposed increase to the existing contract; the commission was originally used to look at law enforcement options and research/propose ideas. The contract is unaffordable due to the loss of revenue from the power plant. The Sheriff previously cut the City's contract price due to a lack of staffing availability for dedicated services. The City has no dedicated services; only the base level response. HCSO says they responded to 2000 calls for the past year. Reports show that most calls are outside of Blue Lake city limits.

The current contract will end in June 2024; current talks have been presentation in nature and not a true negotiation.

The City Manager asks the commission to form an ad hoc commission to look at options for services and to research other communities. The HCSO is calculating Blue Lake's contract cost based upon a per capita allocation; this is different than how he's calculating the costs for Trinidad, who receives the same level of service.

Commissioner Nava: Is there arbitration?

City Manager Mager: Unsure if there is an arbitration clause in the contract, but it is

currently presented as take it or leave it.

Commissioner Nava: What is base level of service?

City Manager Mager: Explained that the City does not have any dedicated service; we have call response only; the deputies do drive through Blue Lake on their way to other areas of the County.

Commissioner Dickinson: What would be different if we didn't have the contract? City Manager Mager: Explains that not much would change, except that the Sheriff would decide what his office would respond to and follow up on.

### Public Comment:

Elise Scafani: Per HCSO, the City is obligated as of July 1 to pay the increase. The City paid the first quarter that included the increase and will have to pay the second quarter in January. The Sheriff is not willing to negotiate and this is the base rate for next year. Doesn't feel that this issue is ad-hoc committee material and doesn't support forming an ad-hoc. The Sheriff will respond to 911 calls but is not obligated to stop crimes.

Jean Lynch: Was offended by prior Blue Lake Police CHief. Appreciates HCSO and the safety they've provided over the past 15 years. Notes BL insurance provider will not insure BL for a Police Dept. Asks what HCSO is supposed to provide as an incorporated city? Honsal stated he was not legally obligated to respond to Blue Lake without a contract. Notes prices across the board have gone up.

### 7. Establish Ad Hoc committee to work on law enforcement actions

Commissioner Dickinson: Can the ad-hoc only have two people?

The commission agrees on the appointment of commissioner Nava and Dickinson to the ad-hoc committee. The ad-hoc will meet with the City Manager soon to discuss the contract and begin research.

### **Public Comment:**

Elise Scafani: Sheriff service and and zero liability is a definite benefit and should be maintained. Ferndalels budget is \$650 for their own police department. We might be able to find funds/grants for base services like federal grants in addition to existing state funds

Jean Lynch: Comments on taxing the residents to support law enforcement services.

# 8. I & H Street Neighborhood Discussion regarding Traffic calming and and parking Options

City Manager Mager: Presents on the City's efforts to increase safety and make Blue Lake's streets more walkable. The City is working with a "walkability" expert to provide feedback on proposed designs and installations. The City is considering options for I Street and H Street to slow down traffic and increase parking options. The City has received feedback on the pop up round-abouts and is looking for community input on future projects.

Commissioner Dickinson: Asks the City to make extra efforts to engage the community in the discussion. Notes houses are very close to the street and people will have a chance to weigh in. Likes the roundabouts in place now, and wishes they were larger and more impactful. Will post the information on Facebook. What are the funding sources for this project.

City Manager Mager: The City was funded to develop a local road safety plan; the plan identifies lower cost solutions to traffic safety and the City is using this document to guide implementation. Grant funding may be available, and the City can use current street fund allocations for some of the projects.

### **Public Comments:**

Elise Scafani: Curious about I street and rationale for need; notes it's important to keep residential parking in mind, so they don't lose theirs. Needs to be a broader invitation than door hangers. Doesn't support diagonal parking as need is not there. Notes that she has never witnessed speeding on I Street.

Jean Lynch: Notes property lines are odd in Blue Lake; may impact parking - surveys may be needed.

Commissioner Crews: What's the biggest reported problem on I Street?

City Manager Mager: Speeding is the number one complaint on I Street and all of the streets in Blue Lake. We have very wide and straight roadways and hard breaks are needed to physically slow down traffic.

Commissioner Crews: Notes door hangers are just a way to start the process and PSC will make recommendations to the Clty Council.

Commissioner Dickinson: When will Dan Burden's recommendations be available?

City Manager Mager: Hopefully at next PSC meeting

Commissioner Crews: Notes inconsistent regulations/application of when sidewalks are needed.

### 9. Powers Creek Updates

MM: City Manager Mager provides an update on the Powers Creek District; the City has broken ground on the bike park. The City has received a lot of support from local volunteers and local businesses on the project.

Commissioner Nava: Are there any additional insurance liabilities associated with the bike park?

City Manager Mager: the bike park will be part of the City's recreation program; liability issues will be addressed through signage and rules and regulations. The City operates many recreation facilities and our insurance provider treats bike parks the same way they treat other recreation facilities and programs. The City has reviewed the project with CIRA to ensure that the park is developed to the appropriate standard for coverage.

Powers Creek Project: The City is working with the Baduwa't Watershed Council on the creek restoration project. Work is being done to survey the creek and finalize construction plans, along with the required environmental and permitting work. The project is expected to go to construction in 2024.

Baduwa't Community: Work on the mixed use development project is moving forward; work is being completed on the designs and environmental reports and studies. The project will be going before the Planning Commission in the near future for consideration of approval. The City is also working on a masterplan of the remaining parcels in the district and will be using the masterplan work to assist in the subdivision of the parcels. This will facilitate additional development in the district.

RV Park and Campground - working with StoryLand Production.

The City corporation yard is under consideration for sale; the Council will consider entering into an agreement with Tasha and Kenneth Eisner for the purchase and development of the property.

The owners of Paradise Cay are interested in purchasing and developing city-owned property in the district; these talks are on-going.

General Information: The City of Blue Lake has received funding to design, engineer and construct improvements to the City's truck route. The first phase of construction funding has been allocated and includes the section of Greenwood Road from the intersection with Blue Lake Boulevard, to the first bend past City Hall.


The City has been working on this project for several years and has been holding stakeholder meetings and community input sessions to gain feedback and input from various user groups, including the elementary school, the fire department, the various trucking companies and industry representatives, the equestrian community, bicyclists, school children, community members and business representatives.




SHN Engineering will be presenting the design to all of the City's commissions, as well as to the City Council. The month of December will be used to finalize stakeholder input.





**General Information:** The City of Blue Lake is working on design and implementation strategies to improve safety on I and H Streets. The City has invited the residents of I and H Streets to attend the Public Safety Commission Meeting, to provide feedback and input regarding potential improvements, including traffic calming measures and parking configurations.

There are several areas of opportunity to improve safety for all user groups; potential improvements may include the following:

- Mini round-abouts
- Stop sign installations
- Parking reconfiguration and Parklet installations
- Bulb-outs
- Raised Crosswalks
- Art Crosswalks
- Signage Installation
- Median Treatment
  - o Landscaped Medians
  - o Painted Treatments
  - o Meanders/Chicanes




Figure 19 provides images taken during the site walk of H and "I" Streets. Note the width of the roadways and lack of pavement markings as well as the vertical curve encountered on H Street near the pedestrian crossing, from which the image was taken.




Figure 19. Site Walk Images Taken at the Crosswalks on "I" (Left) and H (Right) Streets. Potential risk factors were noted including wide lanes, the presence of on-street parking, and issues related to pedestrian crossing such as crossing distance and a lack of warning signage.

# **Strategies**

The following sections offer strategies and countermeasures to address the findings of the data analysis and stakeholder concerns related to challenge areas selected by stakeholders. The section begins by providing suggestions from public survey respondents at the locations of their reports and is followed by engineering countermeasures for both spot improvements and proactive, systemic improvements that can be applied to address challenge areas not otherwise addressed in spot improvements. This is followed by recommendations for non-engineering strategies, including potential methods to improve data collection and collaboration between agencies, recommendations for education campaigns, and suggestions for law enforcement strategies.

### **Public Strategy Suggestions**

In the surveys submitted by the public, respondents were provided the option to suggest strategies to mitigate the incident they witnessed or experienced. Their suggestions were limited to:


- Engineering (Infrastructure change, alter road, signage, etc.)
- Education (Outreach to drivers, pedestrians, etc.)
- Enforcement (Increase law enforcement presence or frequency, DUI checkpoints, etc.)
- Emergency response (Improvement in response time, basic local medical training, etc.)
- Other (Please specify)

- Consider low-cost intersection controls for other intersections along BL Blvd.

- Railroad Ave Address Commercial Traffic Issues
