6. P&R Commission Vacancies - Discussion

Two vacant seats remain on the Parks & Recreation Commission. Bettina Eipper plans to re-apply to be on the Commission for another term and will submit her application to City Hall for Council's consideration.

Council Member Scafani and Director, Emily Wood, discussed whether a commission member must live in Blue Lake to be on the Commission. It was concluded that at least 3 of 5 members must live within the City limits; however at least one member and no more than two can live within the 'sphere of influence' (within 3 miles) of city limits, per Council Member Scafani's knowledge.

A revision of the Community Survey was presented to the Commission for review based on changes suggested at prior meetings. The Commission directed Director Wood to finalize the survey for release to the community at large; with more specific surveys being developed at later dates for review by the Commission (relared to impact of large events, trails, river access, etc.) Council Member Scafani suggested developing graphics demonstrating funding sources for projects, facilities, and programs for Parks & Recreation.
