The City has completed the Library Improvement Project and is processing the close-out of the grant. The City was funded through the Community Development Block Grant (CDBG) Program to remove accessibility barriers at the library, including installation of an ADA accessible walkway, improvements to the library bathroom and access improvements to the library entrance.


Work was completed within the budget established by the CDBG allocation. The City has rejected the initial installation of the handrail due to a defective weld; this handrail is being refabricated and is being installed as a final punch list item.




#### 3. What do you view as the main goal/purpose of the City Council?
