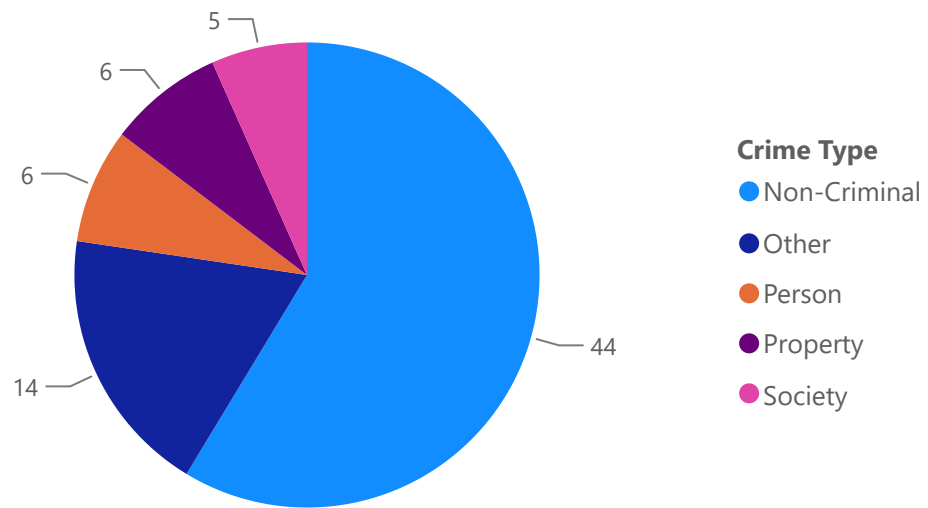

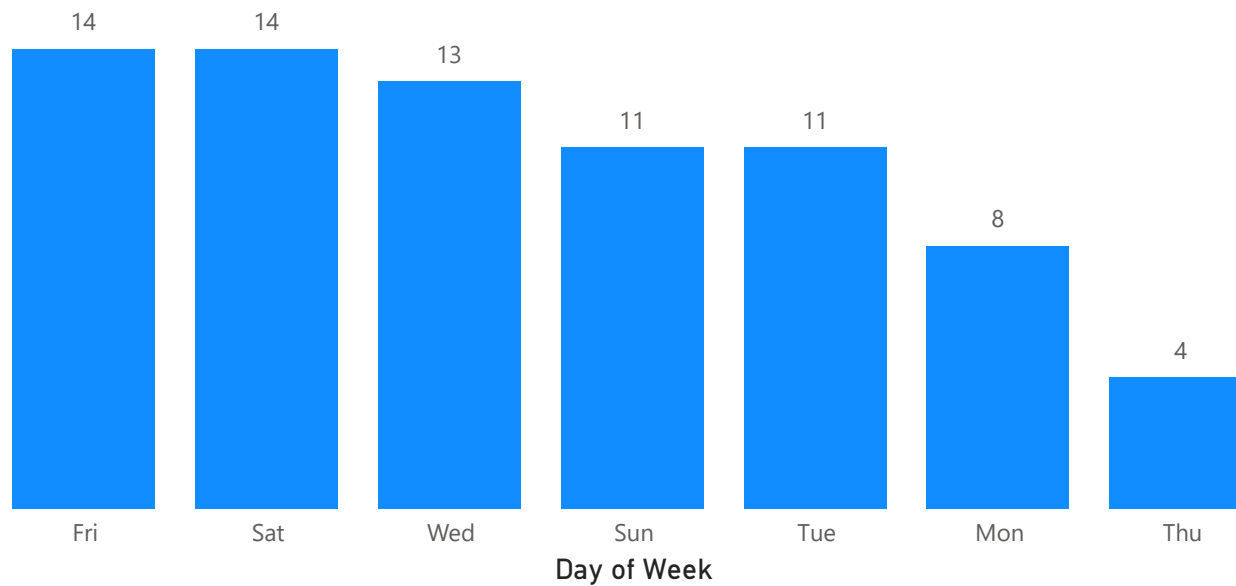

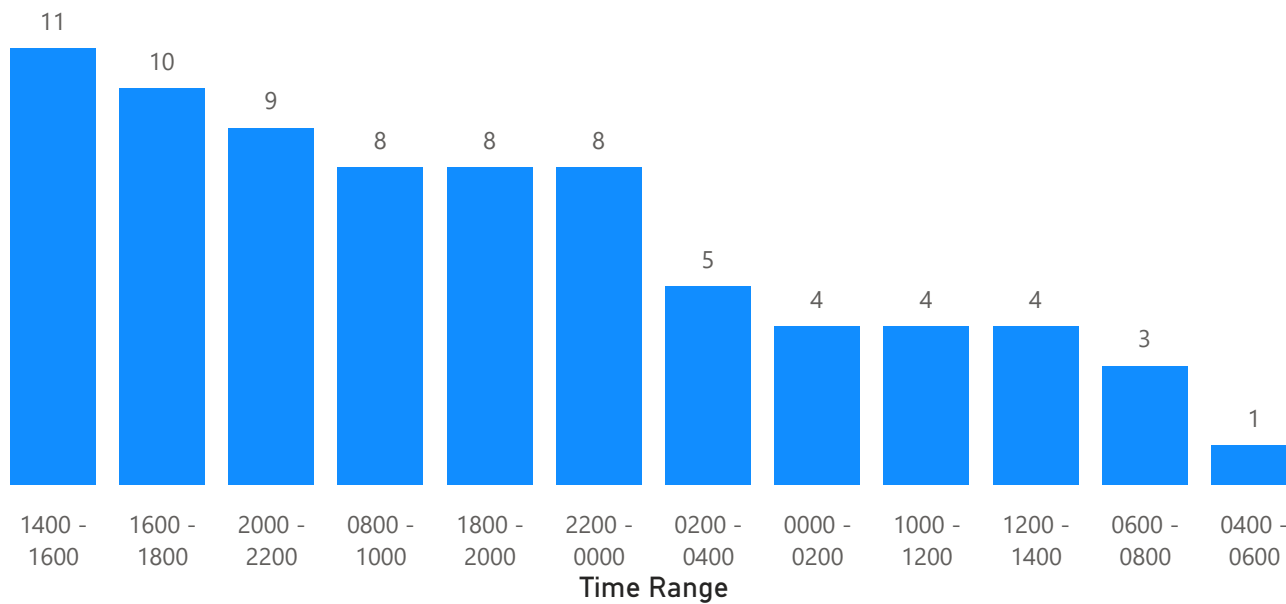




Incident Count by Day of Week

# **Blue Lake Emergency Operation Plan Review 2026**

## **Blue Lake Public Safety Commission Ad-Hoc Committee Goals**

*BLPSC Ad Hoc Committee members: Chair Ted Hales and Vice-Chair Lin Glen*

### **Short Term**

- The Emergency Operations Plan (EOP) will be updated and usable during the Tabletop Emergency Simulation Drill planned for 2027
  
- City Staff will be able use the EOP to prepare for the Tabletop Emergency Simulation drill
  
- After EOP reviews, the PSC will provide City Manager Jennie Short with:
  - +suggestions for updates of outdated information and additions of missing information
  - +an operational/practical pull-out section of the EOP for staff including roles and responsibilities and a current contact list for the people/agencies that staff may need to work with to respond to emergencies, including a plan for annual updates
  
- The Committee will also review Blue Lake's Hazard Mitigation Plan (HMP)
  
- The PSC will provide the Blue Lake City Council with a report on their review of Blue Lake's Emergency Operations Plan and Hazard Mitigation Plan (HMP) including:
  - +the emergencies most likely to happen in Blue Lake
  - +overview of Blue Lake's EOP and HMP
  - +how the city fits into the County and State's emergency systems
  - +awareness of the Blue Lake Rancheria's EOP and HMP and any opportunities for jurisdictions to work together
  - +overview of Humboldt County and 6 other incorporated city's EOP/HMP plans

### **Long term**

- Educate Blue Lake citizens about:
  - +most likely emergencies in Blue Lake
  - +actions citizens can take to prepare themselves and their families for emergencies
  - +emergency preparation, mitigation, and recovery resources available to citizens
  - +resources the city of Blue Lake can offer to citizens and actions the city has taken to prepare for emergencies

# Blue Lake Public Safety Commission 2026 Workplan

## April – December

*“PURPOSE: (the Public Safety Commission) acts as a liaison to the community and the Council in matters relating to public safety; these issues include traffic and pedestrian safety, emergency preparedness and response activities, and neighborhood safety. The Commission will study, report to, and advise the City Council upon any matter regarding public safety and the City’s efforts to control and reduce criminal activities of all types.” - from Blue Lake City Ordinance No. 524*

-Educate citizens on how to bring traffic safety concerns to the City’s attention, make recommendations for traffic safety improvements to the City Council when needed

--MAY/JUNE - ONGOING

-Conduct “Safer 4<sup>th</sup> of July” fireworks reduction education campaign for the Fourth of July

-- JUNE/JULY

-Review the 2017 City of Blue Lake Emergency Operations Plan – goals: make update recommendations to city council, educate public, begin planning for a city simulated disaster response drill for 2027 -- APRIL - ongoing until complete

-Plan and hold annual Blue Lake Community Safety Fair

--JULY - SEPTEMBER

-Educate the public and encourage participation in the statewide earthquake preparedness program – the Great Shakeout on October 15<sup>th</sup>

--SEPTEMBER/OCTOBER

-Assess progress on 2026 Work Plan, create 2027 Work Plan

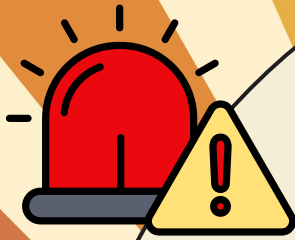
--OCTOBER/NOVEMBER
